2007-2008 Interim Steering Committee Membership: Expanding membership, growing expertise

Following the request of stakeholders at the Plan for Action meeting in April, this summer we expanded the Interim Steering Committee to include an even wider range of skills, knowledge and expertise. The Interim Steering Committee is now a team of 28 highly talented and experienced individuals representing a broad range of perspectives and points of view.

This past spring, the 19 member committee conducted an assessment of their own skills and expertise. By completing a “Skills and Expertise” questionnaire, members identified information such as the networks and organizations they participated in, the topics of research and populations they worked closely with, and self-identified skills and expertise that they bring to the committee. An analysis of the results outlined the strengths of its membership, as well as gaps that needed to be filled. Relying on the findings of this assessment, along with feedback from stakeholders at the April meeting, the Committee identified a list of organizations to propose individuals that might fill these gaps, and invited them to nominate individuals for consideration.

Nominees were invited to complete the “Skills and Expertise” questionnaire used in the Committee’s self-assessment. Committee members balanced the contributions that each individual would bring, taking into consideration factors such as focus or area of expertise and target population, geographic region, skills, and sectors with which they are affiliated.

All candidates were excellent, and represented a wide range of skills and expertise - the Committee was extremely pleased to see such interest. Due to size and budget restrictions, we could not include all nominees on the Steering Committee. However, we look forward to working with all nominees as we invite volunteers to participate on new committees as well as in provincial and territorial workshops throughout the fall and winter.

The key objectives for the Interim Steering Committee for 2007-8 include:

- To continue working with provincial and territorial governments, and all Parliamentarians, to ensure that the Framework is a priority on the public policy agenda. This includes developing innovative policy solutions in a variety of areas impacting lung health (e.g. the environment), while at the same time working to secure implementation funding for the Framework/Plan for Action.
- Together with stakeholders acting to ensure the wide availability of resources from the Asset Map database, while at the same time developing a strategic and transparent, selection criteria process to help in the identification of new resources.
- To continue engaging stakeholders at all levels of the Framework development process, while accurately integrating their feedback and ideas into the Action Plan to be launched in fall/winter 2008.
